The GRRC Red Shed Survey, available to members online and at the March and April membership meetings, has generated many interesting and varied comments. "Are you NUTS?", "It should be rodent proof", "YES for a new building, but PLEASE keep the Red Shed" make a small sampling of the comments added to the survey. 64 surveys were completed and can be reviewed by any member. All comments will be compiled into a single document that will be available at the May meeting. Results will also be available online at www.grrc.org/ by meeting time May 19. According to Dave

Newell, the average survey respondent has been a member for 10.9 years, went to the range 17.5 times last year, and shot in 4.1 matches. The top-ranked responses recommend a Harris facility that should:

- be a learning facility for conceal and carry, NRA range safety programs,
- be a learning facility, e.g. for juniors and NRA Women's camp,
- facilitate all of the GRRC needs for the next 20 years and
- be a year-round facility with a kitchen.

The committee will use the member responses to guide discussion regarding proposed changes at the Red Shed. Thanks to all who took the time to share their ideas and comments.

The next **Membership meeting** will be on May 19th, 1900 hrs **at The Red Shed**. New Business will include a discussion of the use of **tree stands** for the **2010 shooting season**. Board of Directors Meeting Minutes 3/16/09 Kraus Hartig VFW

Call to order – Tom Torborg, President at 7:06 pm, called the meeting to order. Those present were: Tom Torborg, Rick Loye, Laurie A. Pekarik, John Nelson, Harry Crump, Bruce Aune, Dave Secord, Dave Anderson, Ray Hoyt, Kathy Milhulka, Dave Newell, Steve Shimek, and Larry Sparks. Excused: Gary Campbell and Bill Prock.

The VP led the group in the Pledge of Allegiance. A moment of silence was observed for departed members and those serving in the military.

Secretary's Report: Motion to accept as printed in the April newsletter – by Dave Secord with second by Rick Loye. Carried.

Executive Officer's Report: There are two issues. During firing

portion of the last Concealed Carry Class five vehicles crossed over the KD range at the 600 yd line while the range was in operation, even though the gates were closed and the flags were in use. From now on both gates for the road will be chained and padlocked while the KD range is in use. Quick thinking on the part of the shooter to stop shooting alleviated a potentially serious problem. The XO will take action to implement this procedure with appropriate signage attached to both gates. The other issue was the set-up on the 1000 yd line on the KD range for the recent Tactical Shotgun Match. XO wondered if it would be appropriate to have vehicles to transfer people to and from the pits to the firing line. Discussion ensued. NAT as there is not enough attendance at this time to warrant the use of a range owned vehicle for this use. Those in attendance use their own vehicles for that purpose.

Treasurer's Report: Motion by Dave Anderson with second by Harry Crump to accept the report as given. Carried.

Old Business (from the President)

Red Shed Committee Report – There was a meeting on Saturday April 18 @ 4:30 pm. Several components of this study were discussed.

Update on receipt of **General Liability policy** for year 2009-2010 – the endorsement correcting the acreage and total membership has been received. The policy and endorsement will be put in the safety deposit box.

Safety Deposit Box– Tom Torborg, Laurie Pekarik and John Nelson met at the Mounds View Wells Fargo to establish a new box location, audit the contents and to update the signature cards for the checking account.

Update on D and O coverage application – Application has been sent in. No word as yet. Will report when information is available.

What to do with the remaining names that have **no NRA info** – The BOD recommends that those members who have not provided their NRA information will be denied access to the range until they have complied. Their range access gate codes will be deactivated on April 25. Letters will be sent to these members. The 3876 code will disappear by May 1.

PIN's to the Chisago County Fire Department and Jimmie's Johnnies – The BOD recommends that these entities be assigned their own numbers for appropriate range access.

Club Rifle Sale Release form – The forms have been completed for the three rifles that were sold at the Junior Auction in April; forms will be put in the safety deposit box. One rifle remains.

New Business (from the floor)

Final grading and sodding of the 500 yd firing line. Details for this work were presented. This was a 2009-budgeted item. Work will proceed as planned.

Request by Dennis Ordahl that he and his son have use of the remainder of Bud Ordahl's 2009 membership year – After much discussion, Steve Shimek made a motion that on a one-time basis: the remainder of Bud's membership be transferred to his son, Dennis, with full membership privileges, that Bud's grandson can come to the range with Dennis, that in year 2010, both Dennis Ordahl and his son will apply for GRRRC membership following the usual criteria, and that the membership fee for both of \$75 be waived for year 2010. Second by Harry Crump. Carried.

Raising the membership cap from 350 to 400 – Discussion, NAT

Amending the rules for the KD range – Harry Crump made a motion that shooting from any firing point on the KD range with a firearm incapable of impacting the backstop is prohibited. Seconded by Dave Newell. After a lengthy discussion, Tom called the question. With several nays on a voice vote, a hand vote was cast. Majority voted in favor. Carried.

Announcements – next GMM on May 19th, 1900 hrs at Red Shed. If needed, the next BOD meeting will be held one hour prior to the July GMM meeting at the Red Shed.

Motion to adjourn at 8:46 pm by Dave Secord, second by Harry Crump. Carried.

Small Bore Prone League Started May 4

GRRRC is starting up a Small-bore prone league thanks to Kurt Borlaug. This should be fun and challenging. To quote Kurt (CMP Distinguished Marksman) "I thought I was a pretty good shooter until I tried SB prone".

This sanctioned league began Monday, May 4. Matches will be held every Monday (except holidays) through September. You can shoot for score at other times during the week as long as another shooter witnesses/signs off on your score. On Mondays, shooting will occur from 3:00-7:30 pm with relays starting every half-hour. This game is a great training tool for High Power. Kurt says it will improve your shooting measurably. The Small-Bore range was constructed on the spring work weekend at GRRRC. It's on the Blackpowder Range and should be challenging as the funneling of air is constant when the wind blows.

Here are a few reminders:

- 1) Each shooter is allowed a personal wind indicator just in front of them. It can be an arrow on a stick (shortened) a windmill or small post with a length of surveyor's tape. It can't interfere with fellow shooters.
- 2) There will be a "day shift" for shooters during the daytime.
- 3) You are able to shoot two matches ahead, and make up any matches missed.
- 4) The match is NRA sanctioned so scores will be submitted.
- 5) Distances shot will range from 50 to 100 yards.
- 6) There will be a "Sporter" class for shooters who do not possess target-style rifles or equipment. This would include semi-autos, scopes, and levers. Remember that small-bore is fired one round at a time. No "Rapid Fire" is allowed. This is a precision game.
- 7) 6400 total points; Four 1600 point matches, two with irons and two with any-sight. One yard line per week. [If I understand correctly, each week we will shoot 40 shots for a total possible 400 points.]
- 8) Have fun!!

GRRC Membership Meeting 3/17/09

The President called the meeting to order at 7:03 pm, with a Quorum present. The Vice-President led the membership in the Pledge of Allegiance and a moment of silence was observed to honor absent companions and those serving in the military.

President Tom Torborg introduced Donald LaCroix, Commander Elect of Kraus Hartig VFW Club. He welcomed everyone and extended an invitation to any veteran who meets the requirements; the Post pays the first year membership fee. Mentioned the special menu offerings during each month.

The Secretary's Report was published in the April Newsletter. A motion made by Dave Secord and with second by Dave Newell to accept the Secretary's Report as printed. Motion carried.

Recap of 20 April 2009 BODM:

- * XO will implement locking and chaining the gates at the 600 yd firing line when the KD range is in use for any reason. Appropriate signage will be placed on both gates. Be sure to observe this, as there will be live fire crossing this roadway when the gates are locked.
- * On a one-time basis BOD recommends the transfer of Bud Ordahl's membership to his son, Dennis for remainder of 2009. Dennis Ordahl and his son will follow the usual membership requirements to join individually in 2010.
- * BOD recommends proceeding with final grading/sodding of 500yd firing line, which was a budgeted item for 2009.

Also, refer back to the BOD minutes for motion made to change the KD Range Rules. An irrigation system is to be installed from 600-1000 yd firing lines. accept the Second Readings as a group. Carried. Motion made by Dave Newell with second by Dave Secord to accept the group as members of GRRC. Carried. The new members and guests returned to the meeting room. The Vice-President welcomed 6 new members. Pay your fees to the Secretary after the meeting.

CMP Marksman: Gordon Kordosky



Gordon Kordosky earned the US Air Force Distinguished Rifleman Badge in 1986 as a member of the Minnesota Air National Guard/ During his 30 years of service, Gordy started shooting in 1966 at the old Johnsville range.. He was assigned as Base Marksmanship Coordinator from 1969-1992 when he retired from the ANG.



In 1967, Gordy started shooting with the National Guard Rifle Team, eventually taking over the team captaincy from Jack Kollmer who then concentrated on serving as armorer and team coach until he retired. Jack convinced Gordy to take the job by issuing him one of the better tested M-14s that Jack had built. Within two years Gordy earned his Distinguished Badge.

The Air Force competition weapon of choice was the M1 Garand with which Gordy earned his first 8 points in 1976 at the Red Wing Regional. After some years the Air Force converted its inventory from .30-06 to .308 mainly by using a sub-chamber insert. That worked well for quite a while, but it came loose during a match in Little Rock- and became the deciding factor in Gordy's switching to the M14. With that weapon, Gordy got his remaining points at the Winston P. Wilson National Guard Championships in Little Rock, AR, again at the Red Wing Regional and the 4th Army Area Matches at Camp Perry.

Through their efforts, Gordy and Jack introduced the sport of High Power rifle shooting to several hundred National Guard members. They conducted tryouts annually to field a team- of whom 50% of the shooters had to be new to the firing team- for each military match. Some stayed with the program and continued shooting. Many did not. The training requirements and the logistics were many, but the success of the program was confirmed by its awards, both team and individual, and the fact the Minnesota was consistently one of the top 10 National Guard Teams throughout those years.

Tactical Shotgun Match Held 3/24 at Harris

24 scattergunners celebrated GRRC's 5th Annual **Tactical Shotgun Match** with four fun stages of shooting. The shooters showed up to compete on a gorgeous spring morning and afternoon. Stages consisted of engaging steel poppers and plates, swingers with IPSC targets attached, drop turners with IPSC targets attached, stationary clay birds, flying clay birds, and bowling pins to knock off their perches.

Shooters competed in three divisions: *Open*, *Limited*, and *Heavy Metal*. Heavy Metal sounds like something coming out of a Kiss concert, but is the division which utilizes pump shotguns. In a Three-Gun Match, the pump shotgun is included with a .308 semi-auto rifle like an AR-10 or FN FAL. Pistol competitors must use a .45 ACP pistol of any variation such as a single stack 1911, or a double stack Glock model 21.

The other divisions in Tactical Shotgun matches are Open and Tactical. If you were shooting a pistol, it might include a Limited class pistol, which is a semi-auto shotgun without optics and a tubular magazine holding eight shells. In Open almost anything goes. In this class you might see Saigas which are a Kalasnikov-designed shotgun incorporating muzzle brakes and detachable magazines. The more frequently used guns are either Remington 1100's or Benellis tricked out with aftermarket magazine tubes holding 13+ shells and loading gates that incorporate "Tech" loaders. These can throw eight shells in the gun in a blink of an eye.

Top shooters for 2009 were: **Bob Mills**- Open; **Keith Ulfers**- Limited; and **Tom Crazy**- Heavy Metal. I would like to thank Laurie Pekarik for providing outstanding "made from scratch" soup along with the old fashioned wieners. The match was given accolades from the competitors who enjoyed the hot meal and the day of scattergunning!
